


Figure 1 – Login User use case 1.1




Figure 2 – Logout User use case 1.2




Figure 3 - View Profile Details use case 1.3




Figure 4 - Reset Password use case 1.4




Figure 5 - Forgot Password use case 1.5




Figure 6 - Register Customer use case 1.6




Figure 7 - Update Profile Details use case 1.7




Figure 8 - Update Email Address use case 1.8




Figure 9 - Register User use case 2.1




Figure 10 - Search User use case 2.2




Figure 11- Update User Details use case 2.3




Figure 12- Delete User use case 2.4




Figure 13 - Send Payment Reminder use case 3.1




Figure 14 – Capture Proof of Payment 3.2




Figure 15 – Add Product use case 4.1




Figure 16 - Search Product use case 4.2




Figure 17 - Update Product use case 4.3




Figure 18 - Delete Product use case 4.4




Figure 19 - Add Product Category use case 4.5




Figure 20 - Search Product Category use case 4.6




Figure 21 - Update Product Category use case 4.7




Figure 22 - Delete Product Category use case 4.8




Figure 23 - Add Product Brand use case 4.9




Figure 24 - Search Product Brand use case 4.10




Figure 25 - Update Product Brand use case 4.11




Figure 26 - Delete Product Brand use case 4.12




Figure 27 - Create Return Reason use case 4.13




Figure 28 - Search Return Reason use case 4.14




Figure 29 - Update Return Reason use case 4.15




Figure 30 - Delete Return Reason use case 4.16




Figure 31 - Browse Product Catalogue use case 4.17




Figure 32 - Configure Product use case 4.18




Figure 33 – Add Item(s) to Cart use case 5.1




Figure 34 – Update Cart use case 5.2




Figure 35 – Remove Item(s) from Cart use case 5.3




Figure 36 – View Cart use case 5.4




Figure 37 – Checkout Cart use case 5.5




Figure 38 – Make Payment use case 5.6




Figure 39 – View Orders Overview use case 5.7




Figure 40– Search Order use case 5.8




Figure 41 – Query Order use case 5.9




Figure 42 – Review Order use case 5.10




Figure 43 – Create Courier use case 5.11




Figure 44 –Search Courier use case 5.12




Figure 45 – Update Courier use case 5.13




Figure 46 – Delete Courier use case 5.14




Figure 47 – Search Placed Order use case 5.15




Figure 48 – View Placed Order use case 5.16




Figure 49 – Cancel Placed Order use case 5.17




Figure 50 – Cancel Reseller Order use case 5.18




Figure 51 – Approve/Reject Reseller Order use case 5.19




Figure 52 – Dispatch Order use case 5.20




Figure 53 –Log Back Order use case 5.21




Figure 54 –Confirm Order use case 5.22




Figure 55 – Reject Order use case 5.23




Figure 56 – Send Order Confirmation Reminder use case 5.24




Figure 57 – Update Order Confirmation Time use case 5.25




Figure 58 - Create Query Reason use case 6.1




Figure 59 - Search Query Reason use case 6.2




Figure 60 - Update Query Reason use case 6.3




Figure 61 -Delete Query Reason use case 6.4




Figure 62 - Review Order Query use case 6.5




Figure 63 -View Order Query Feedback use case 6.6




Figure 64 - Create Review Reason use case 7.1




Figure 65- Search Review Reason use case 7.2




Figure 66 - Update Review Reason use case 7.3




Figure 67 - Delete Review Reason use case 7.4




Figure 68 - View Order Review use case 7.5




Figure 69 – Create Inventory Item use case 8.1




Figure 70 – Search Inventory Item use case 8.2




Figure 71 – Update Inventory Item use case 8.3




Figure 72 – Delete Inventory Item use case 8.4




Figure 73 – Create Inventory Type use case 8.5




Figure 74 – Search Inventory Type use case 8.6




Figure 75 – Update Inventory Type use case 8.7




Figure 76 – Delete Inventory Type use case 8.8




Figure 77 – Create Write-Off Reason use case 8.9




Figure 78 – Search Write-Off Reason use case 8.10




Figure 79 –Update Write-Off Reason use case 8.11




Figure 80 – Delete Write-Off Reason use case 8.12




Figure 81 –Write-Off Inventory use case 8.13




Figure 82 –Write-Off Product use case 8.1A




Figure 83 – Convert Inventory to Product use case 8.15




Figure 84 – Search Procured Inventory use case 8.16




Figure 85 –View Procured Inventory Details use case 8.17




Figure 86 –Capture Procured Inventory use case 8.18




Figure 87 –Capture Returned Product use case 8.19




Figure 88 – Package Order use case 8.20




Figure 89 –Send Low Inventory Alert use case 8.21




Figure 90 – Send Inventory Out of Stock Alert use case 8.22




Figure 91 – Create Country use case 9.1




Figure 92 – Search Country use case 9.2




Figure 93 – Update Country use case 9.3




Figure 94 – Delete Country use case 9.4




Figure 95 – Add Province use case 9.5




Figure 96 – Search Province use case 9.6




Figure 97 – Update Province use case 9.7




Figure 98 – Delete Province use case 9.8




Figure 99 –Create City use case 9.9




Figure 100 – Search City use case 9.10




Figure 101– Update City use case 9.11




Figure 102– Delete City use case 9.12




Figure 103 – Add Suburb use case 9.13




Figure 104 –Search Suburb use case 9.14




Figure 105 –Update Suburb use case 9.15




Figure 106 –Delete Suburb use case 9.16




Figure 107 - Generate Inventory List Report use case 10.1




Figure 108 - Generate Sales (by Top 5 Clients) Report use case 10.2




Figure 109 - Generate Product List Report use case 10.3




Figure 110 - Generate Customer List Report use case 10.4




Figure 111 - Generate Reseller List Report use case 10.5




Figure 112 - Generate Produced Products Report use case 10.6




Figure 113 - Generate Order (by Status) Report use case 10.7




Figure 114 - Generate Order (by Region) Report use case 10.8




Figure 115 - Generate Sales (by Product) Report use case 10.9




Figure 116 - Generate Sales (by Month) Report use case 10.10




Figure 117 - View Dashboard Overview use case 10.11




Figure 118 – Create Supplier use case 11.1




Figure 119 – Search Supplier use case 11.2




Figure 120 – Update Supplier use case 11.3




Figure 121 – Delete Supplier use case 11.4




Figure 122 – Send Supplier Order use case 11.5




Figure 123 – View Deliveries use case 12.1




Figure 124 – View Previous Deliveries use case 12.2




Figure 125 – Confirm Delivery use case 12.3




Figure 126 – Create VAT use case 13.1




Figure 127 – Search VAT use case 13.2




Figure 128 – Update VAT Details use case 13.3




Figure 129 – Delete VAT use case 13.4




Figure 130 – Update Reseller Credit Settlement Time use case 14.1




Figure 131 – Add Video use case 15.1




Figure 132 – Search Video use case 15.2




Figure 133 – Update Video Details use case 15.3




Figure 134 – Delete Video use case 15.4




Figure 135 – View Video use case 15.5




Figure 136 - View Help Document use case 16.1
